

B. Summary of Operations

During two underway periods in January (10-14 & 17-20) BIDDLE conducted a technical evaluation of the Navy's prototype ECM system, SHORTSTOP. The evaluation was conducted in the Virginia Capes Operation Area (VACAPES) by ship's force and factory representatives from ITT Avionics.

The operational evaluation commenced immediately afterward. Tests were conducted during the weeks of 24-28 January, 31 January - 4 February, and 14-18 February in the VACAPES OP AREA. The final operational tests were conducted in the Jacksonville (Florida) Operation Area, 22-25 February and 28 February-3 March. (On 9 February during a week inport for maintenance the ship held its annual Ship's Party celebrating the fifth anniversary of BIDDLE's commissioning.) The weekend of 26-27 February was spent in Port Everglades, Florida.

BIDDLE was assigned Restricted Availability to the Norfolk Naval Shipyard in March for modification to accept the Navy's Light Airborne Multi-Purpose System (LAMPS). All work was done at the D&S Piers by shipyard workers in an around-the-clock schedule. Work on LAMPS modification was completed in early April.

On April 8th the ship was ordered made ready for immediate deployment to the Southeast Asia combat zone. On Wednesday, April 12th, BIDDLE got underway from D&S Piers with USS MULLINNIX (DD-944) for its deployment. The two ships were joined on April 14th by USS GLENNON (DD-840) from Charleston, South Carolina and USS SANSFIELD (DD-839) from Mayport, Florida. (The OTC of the Transit Group was CAPT T. HUGHES, Commander Destroyer Squadron THIRTY-TWO, embarked in MULLINNIX.) The group transited the Panama Canal on April 16th and began the Pacific crossing after a fuel stop at the U.S. Naval Station, Rodman, Canal Zone that same day. On April 26th the Transit Group stopped overnight in Pearl Harbor for fuel and supplies at the Pacific Missile Range Facility, Hawaii. One firing was rated a success and the other was undetermined. BIDDLE rejoined the group on April 30th off Midway Island. The group proceeded via Guam, for fuel stop on May 7th, and arrived Subic Bay, Phillipines on 11 May. BIDDLE spent three days inport Subic Bay unloading combat supplies and equipment and got underway for the combat zone on 14 May. On 15 May BIDDLE entered the combat zone and became a part of Task Force 77 in the Gulf of Tonkin. The ship arrived at the Northern Search and Rescue Station (NSAR) on 16 May to relieve USS STERETT (DLG-31). BIDDLE operated from this station until late June as Air AAW and Search and Rescue (SAR) picket ship and as an ELINT collection ship. BIDDLE returned to Subic Bay on 26 June for maintenance and crew liberty.

On July 3rd Captain Edward W. CARTER, III relieved Captain William O. McDANIEL as Commanding Officer in a ceremony onboard the ship in Subic Bay. On July 4th BIDDLE left Subic Bay to return to the combat zone relieving USS ENGLAND (DLG-22) on NSAR (6 July). On 13 BIDDLE was relieved by USS LONG BEACH (CGN-9) and in turn relieved USS STERETT as Positive Identification and Radar Advisory Zone (PIRAZ) ship. BIDDLE's roles on PIRAZ station were strike control ship for USN and USAF air strikes against North Vietnam, AAW and SAR picket ship, and ELINT collection ship.

BIDDLE was attacked on the night of 19 July by five MIG aircraft in two raids. BIDDLE destroyed one MIG from the first raid with Terrier missiles and possibly one from the second raid with five-inch and Three-inch gun fire. The other MIGs were driven off and BIDDLE received no damage. On 29 July BIDDLE assumed the additional role of SAR Coordinator for all forces in the Gulf of Tonkin. On August 29th USS LONG BEACH relieved BIDDLE as PIRAZ ship and BIDDLE departed the Gulf for three days in Hong Kong (12-15 August) and two days in Subic Bay (17-19 August). BIDDLE left Subic Bay on 20 August for NSAR station to relieve USS ENGLAND on 22 August. On 27 August USS TRUXTUN (DLGN-35) relieved BIDDLE on NSAR and BIDDLE, in turn, relieved USS LONG BEACH on PIRAZ on 29 August.

On 1 September, Task Force 77 evacuated its station in the Gulf of Tonkin to avoid Typhoon Elsie. On 3 September BIDDLE relieved COMDESRON 19, embarked in LONG BEACH, as SAR Coordinator. On 4 September TF 77 returned to stations and normal operations were resumed in the Gulf. BIDDLE was relieved as PIRAZ ship by USS LONG BEACH on 17 September for return to Subic Bay to off-load equipment (20-24 September).

During its three line periods in the Gulf of Tonkin, totaling 105 days in the combat zone, BIDDLE directed 102 Navy and 56 Air Force strikes over North Vietnam. BIDDLE's air intercept controllers directed the destruction of 13 enemy MIG's, 7 by U.S. Navy Fighters and 6 by U.S.A.F. fighters. One additional MIG was destroyed by ship's missiles. BIDDLE directed and/or conducted Combat Search and Rescue Operations which were responsible for the rescue of 5 Navy, 8 Air Force and 4 Marine pilots downed on combat missions. The ship's LAMPS Detachment (HSL-30 Det 4 from NAS Lakehurst, N.J.) flew a total of 711.6 flight hours on ESM/ASMD patrols and CSAR missions during the deployment. During these flights the LAMPS helo conducted extensive electronics surveillance of the North Vietnamese coast, and made the first combat SAR rescue by an SH-2 LAMPS helo on the night of 11 September.

BIDDLE departed Subic Bay on 25 September for Norfolk without the Commanding Officer, who had been ordered to Pearl Harbor to brief CINCPAC, CINCPACFLT and CINCPACAF on Navy--Air Force operations in the Gulf of Tonkin. BIDDLE made a fuel stop in Guam on 28 September and continued on to Pearl Harbor arriving on 4 October. Captain CARTER rejoined the ship and BIDDLE was underway from Pearl Harbor on 6 October with RADM J. E. RICE, COMNAVELEX, onboard as far as San Diego to observe SHORTSTOP tests which were conducted 6-8 October in the Hawaii OPAREA. On 9 October BIDDLE rendezvoused with MULLINNIX, GLENNON, and SANSFIELD for the transit back to the East Coast by way of San Diego (inport 13-15 October) and the Panama Canal (22 October). BIDDLE arrived in Norfolk on 26 October and went into standown during the following three weeks.

BIDDLE spent the remainder of the year at D&S Piers in Norfolk. During 15-17 November the ship completed Naval Technical Proficiency Inspection training and successfully completed the inspection during 11-12 December. During 20-27 December BIDDLE was assigned as East Coast Ready Duty Ship but was not required to leave port.
